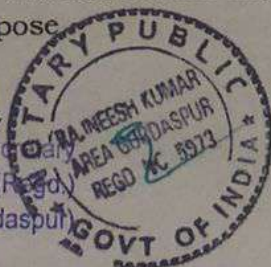
With reference to the application letter received from you and the correspondence with the school after that, I accepted the application for Doaba Public School Kot Santokh Rai Block Dhariwal-2 from Class I to Class VIII for three years from 01-04-2020 to 31-03-2023.

This approval will be considered only after the fulfillment of the following conditions.

Conditions:-

1. Time period of approval cannot be extended and in any case there is no any commitment for approval/affiliation after the eighth grade.
2. School will strictly obey the right of children for free and Compulsory education rights act 2009 (Annexure 1) and Children's Compulsory and free education Rule 2011 (Annexure 2).
3. The school will enroll in the first class and 25 percent of the students will be eligible for free and compulsory education from all the students who are in the weaker sections and non-profit categories which will be in their neighborhood until the end of elementary education. This rule will also apply to the pre-primary category.
4. For the students shown in paragraph no. 3, school will fulfill the subsection 2 of Section 12 and for this fulfillment will provide a separate bank account.
5. Schools will not collect any fees forcibly from any parent or guardian for any purpose

6. School will not refuse to any one for admission:-
 - (a) Any child who does not have proof of birth.
 - (b) If such child is given admission or admitted (to be admitted) during the extended period.
 - (c) On the basis of religion, caste or place of birth.
7. The school will ensure:
 - (a) No enrolled student can be stopped or removed from any category until his elementary education is completed.
 - (b) No student will be punished physically or mentally.
 - (c) No student will need to pass any board exam before completing elementary education
 - (d) According to rule 21, each student will be certified after getting elementary education
 - (e) Students with disabilities, disabled or any other needy students will be admitted according to under the law
 - (f) According to sub-section (1) of section 23, the appointed teachers meet their educational qualifications. If they are already appointed, they will complete their minimum required educational qualifications within five years of joining the date of the law.
 - (g) Under the rules as provided in Section 24 of the Education Act and subsection (1), the teachers will perform their duties.
 - (h) Teachers will not be able to include themselves in any type of private tuitions
8. The school will follow the schedule and curriculum fixed by the eligible administrative organizations/authorities.
9. The school will enroll the children according to the proportion provided in section 19 of the law.
10. The school will abide the criteria according to Section 19 of the Right to Education Act. The facilities that are shown according to the previous inspection, if any, are as follows: -

15. The school's audit should be registered by the certified accountant /CA and the accounting should be made in accordance with the rules. The information of each year will be sent to the District Education Officer (EE).

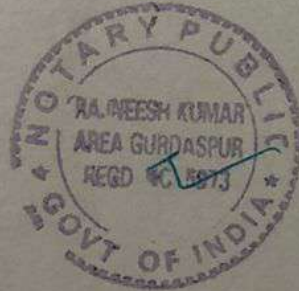
16. Yours school's recognized affiliate number is mentioned in the above mentioned list. (Please note it and be shown later in the future, in any letter correspondence.)
